
MAT 1025 Inelastic 10-Ne-20  
 Cross Section -12.35 To 9999. %











MAT 1025 (n, n') 2α 10-Ne-20  
 Cross Section -100.0 To 3991. %




MAT 1025 (n,n') p α 10-Ne-20



 Cross Section -100.0 To 26.67 %





 Cross Section -1.097 To 23.96 %





 Cross Section -1.059 To 103.5 %











 Cross Section 0.000 To 117.9 %













 Cross Section -100.0 To 302.2 %




MAT 1025 (n,d) 10-Ne-20  
 Cross Section -100.0 To 34.37 %






 Cross Section -100.0 To 72.28 %




MAT 1025 (n, He-3) 10-Ne-20  
 Cross Section -100.0 To 163.2 %











MAT 1025 (n,p)  $\alpha$  10-Ne-20  
 Cross Section -100.0 To 31.20 %






MAT 1025 Hydrogen Production 10-Ne-20


Deuterium Production 10-Ne-20






MAT 1025 Kerma total (eV-barns) 10-Ne-20








MAT 1025 Kerma inelastic (mt51-91) 10-Ne-20  
 Cross Section -5.991 To 9999. %








Kerma capture (mt102) 10-Ne-20






